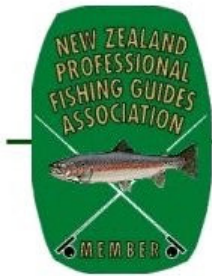

The first year's subscription (\$450.00 plus GST is \$517.50) and is payable within one month of acceptance of the application for membership of NZPFGA.

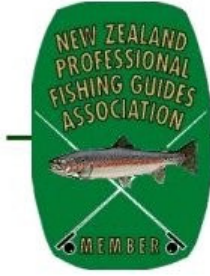

CODE OF ETHICS

All members will at all times in the operation of their businesses, and at any other times where their actions might reflect upon any other members of the Association, ensure that they:

1. Conduct themselves in the field in a professional manner and abide by the laws of the land.
2. Hold the safety and welfare of the client paramount.
3. Do the best for the client, ensuring that no personal preference of the guide should interfere with the client's success or enjoyment.
4. Show respect for fish and fisheries, and not become involved in any action which will knowingly result in damage to either.
5. Actively promote the concept of Catch and Release, allowing for the requirements of good fisheries management and a client's right to take fish for eating or a trophy for mounting.
6. Respect the rights of the recreational angler, the land owner and other sports persons.
7. Never mislead clients in advertising or misrepresent the Association.
